## I PROFILE OF THE JOURNAL EDITOR-IN-CHIEF XIAOHE LU

Ms Xiaohe Lu currently is Professor at Institute of Philosophy, Executive Director of Center for Business Ethics Studies, Shanghai Academy of Social Sciences. She is the author of over 70 articles on business ethics and the author of the works: *Out of Jungle—On the Emergence and Development of Business Ethics* (1999), *Studies on Business Ethics* (2008); co-editor of four book series: *New Studies on Business Ethics Book Series* ( 7 books, 2002), *International Forum Series on Business Ethics* ( 4 books, 2003-) including *Developing Business Ethics in China* (Palgrave Macmillan, USA, 2006), *Translation Book Series on Business Ethics* (5 books, 2002), *New Translation Book Series on Business Ethics* (5 books, 2006-2008), and translator of Chinese versions of the books: *Ethics Since 1900* (1987); *Structural Anthropology* (1989); *Selected Vico's Writings* (1997); and *Trust and Business: Barriers and Bridges* (2003). In 1999, she co-created the Center for Business Ethics of SASS, organized many conferences on business ethics for the Center, including “International Conference on Developing Business Ethics in China” (2002), “Freedom and Responsibilities for Business in China: Governments, Corporations, and Civil Society Organizations (2006). In 2003, she created “International Series Forum on Business Ethics” for promoting the exchanging between scholars and business people, and between Chinese and non Chinese scholars and practitioners on the topics of concern to business ethics and the society. She served on the Council of the China Association of Ethics (2000-2008) and on ISBEE (International Society of Business, Economics and Ethics)’s Executive Committee (2000-2008). Currently, she is Executive Member of Council, China Association of Ethics (CAE), Vice President of Shanghai Association of Ethics (SAE) and Director of the Business Ethics Committee of SAE, and member of editorial Review Board of *Issues in Business Ethics* since 2009.
